Credit Repair After Bankruptcy

A New Service Coming Soon From Pacific Law Center

Pacific Law Center attorney Don Bokovoy has created a new service for PLC clients and non-clients: offering credit repair to bankruptcy clients.

Bokovoy explains:

“In its never-ending quest to provide perfect service to our clients, Pacific Law Center is researching our ability to offer credit repair to bankruptcy clients. Many times, the credit reporting bureaus will list a bankruptcy -- they’ll show an account that was in bankruptcy and then they’ll show the account as a charged-off account. So, the person ends up with a bankruptcy and two negative accounts. This will cause a credit score to go down.”

How will Pacific Law Center attorneys fix this problem?

“What our services will be offering is the ability to go into the credit bureaus and make certain they delete incorrect or outdated information and stop duplicity of negative information. The result that we would be working toward is increasing the actual credit score of our clients. This is part of maintaining a service and a connection with our clients so they realize we are a full service firm. We’re going to be doing all we can to help our clients.”

There are currently no known firms offering this service, and Bokovoy hopes Pacific Law Center will help at least 1,000 people per year.

When will Pacific Law Center’s credit repair be available to bankruptcy clients?

“If you were at Disneyland, this would be the new ride with the curtain around it. We’re working on a May 1 start date as we develop the program. This is a unique service because of what it will do for our clients. It continues the healing process that bankruptcy should be. We’ve already had interest from one

Pacific Law Center Wins Reprieve

Early Release for Grieving Client

Earlier last month, Pacific Law Center received a phone call from Pat Boyle, the father of 27 year-old Cameron Boyle. Cameron was six months through a one year sentence in a county jail.

“She had been sick for a while, so it was hard to not be there for her,” Boyle said. “We had a close family and I used to see her every week, plus the usual get-togethers for Thanksgiving and other holidays.”

Pat also hoped Cameron could be permanently released from prison.

Attorneys at Pacific Law Center immediately went to work.

PLC paralegal Craig Nunnally and attorney Terry Allen pushed for Boyle’s sentence to allow for an early release. Nunnally contacted the facility where Boyle was detained, spoke to his corrections counselor, and found a legal method to get him released.

Another Pacific Law Center attorney, Tom Booth, appeared in court the same day. Within 24 hours, Cameron was sent home for good.

“It was a really sad reason to get a reprieve, but my attorneys did their job,” Boyle said. “Obviously, I was very happy to be free again.” ■

All ended well for Melvina N., an 80-year old woman who called Pacific Law Center to help her claim bankruptcy.

“I kind of got in a mess when my husband passed away,” Melvina said. “He left me with some bills and I tried to keep my finances in check, but I couldn’t. The credit card bills kept getting worse, up to about \$50,000.00.”

Pacific Law Center’s Jeffrey Curtis stepped in to help.

“We basically helped Melvina re-do her budget,” Curtis said. “After doing the budget, she has piece of mind because that financial burden is gone and she has money for everything she needs. She would have basically been buried in debt the way credit card interest rates are.”

18 Year-Old Woman Avoids Jail Time, Felony Conviction

Pacific Law Center attorney Richard Berkon recently helped an 18 year-old woman, with no previous criminal record, avoid jail time and a felony conviction.

“My client, Esmira, worked as a cashier at a Macy’s in the

“I missed my wife after she got out of the restroom because there was a line of people waiting to buy memorabilia,” John said. “But, I caught up with her outside. She was pretty upset and crying, so I tried to help calm her down. I guess these two guys thought I was trying to hurt her, but that has never been an issue with my wife and I.”

One of the men attacked John, a martial arts instructor in the U.S. Marine Corps. John acted in self-defense, but the fight ended with police arresting him for battery.

Pacific Law Center attorney Matthew Spiegel represented John, and convinced the District Attorney’s office to drop the charge just before it went to trial.

“John had a perfect record in the military with meritorious promotions,” Spiegel said. “He was actually up for a promotion (to Sergeant) that was being held because of his pending criminal case. By getting the charge dismissed, it helped him to continue moving up the ranks.”

John said he was impressed by the personal attention Spiegel gave his case.

“Matt did a great job,” John said. “He handles himself very professionally and I’m very happy with the results. Every time I called and left a message, Matt responded right away--much faster than I’d expect from an attorney.”

And his promotion to Sergeant?

“Once all the charges were dropped and the case was dismissed, my promotion was backdated to November first,” John said. “I was paid for it and everything.” ■

South Bay. She was charged with Felony Grand Theft after activating \$3,500.00 in Macy’s gift cards for her use. Because she had family support, no previous record and apologized for her mistake, we were able to avoid a strict sentence.”

Instead, Esmira was asked to repay the \$3,500.00 and complete community service work.

Berkon feels she learned her lesson.

“We all make mistakes when we’re young, some bigger than others,” he said. “Esmira regretted her actions and felt very embarrassed. I think our settlement was fair and she can finish college and move on without a felony conviction on her record.”

Esmira’s father, Jeronimo, said he was very pleased with Berkon’s work.

“Mr. Berkon was very kind and was always there for Esmira and me,” Jeronimo said. “Whenever we called with questions or concerns he always responded right away. We were very pleased with how he handled the case and how the staff of Pacific Law Center treated us.” ■



Attorney Q&A

Client Question: *My mother has taken Zelnorm for irritable bowel syndrome for approximately three months and she suffered a stroke. Is it possible that this drug caused it?*

Phillips and Associates attorney Lowell Finson responds:

“Yes, and why is it possible? Because the FDA did a study—called a Meta-analysis—which means they took numerous professional studies and found a result. The studies indicated that Zelnorm caused an unreasonable risk of cardiovascular or thrombotic events—heart attack or stroke. The FDA told Novartis, the manufacturer, to take a look at their drug and consider withdrawing it from the market. Novartis did withdraw, which was sort of an admission that maybe these results were a little bit scarier than originally thought.”

Just how soon can people feel the side effects of Zelnorm?

“It’s way too early to tell. My suspicion would be that it could be almost immediately, but then again, chances are that the longer the use, the more the symptoms are likely to occur. We know how these drugs tend to work, but it’s not so easy (with this drug) to tell *why* people are having heart attacks and strokes.

About three years ago there was a warning letter sent to doctors who prescribe Zelnorm, indicating that it may cause excessive diarrhea and dehydration—now that alone could prompt a heart attack or stroke. You’re sick, very dry, and there aren’t enough electrolytes in your body. These factors alone can lead to heart attack or stroke depending on the individual. A lot of research still needs to be done, but this drug has already proven to be very dangerous.” ■
